ADMINISTRATIVE

Mayor's Appointments

Mayor Lumpkins requested a motion to reappoint Mark Dittmer to the Zoning Board for a term of four years.

MOTION

A motion was made by Trustee Meeks, Seconded by Trustee Mahoney and unanimously passed to approve the appointment of Mark Dittmer to the Zoning Board for a term of four years.

Mayor Lumpkins invited Chief Roehlk to come up and speak about the new officer we are hiring, Sandy Molidor. Chief Roehlk stated that Sandy is well known and respected in the area and he thinks that we are very lucky to have her. She is a well-trained officer and she lives close by. Mayor Lumpkins stated that we had removed bonuses from the budget about three years ago and have decided to give them back to full and part time employees since the Village is doing so well.

Mayor Lumpkins requested a motion to approve the budget for the Drug

Seizure Fund.

MOTION A motion was made by Trustee Walker, Seconded by Trustee Mahoney

and unanimously passed to approve the budget for the Drug Seizure Fund.

Mayor Lumpkins requested a motion to approve the budget for the

Community Development Block Grant Fund.

MOTION A motion was made by Trustee Meeks, Seconded by Trustee Walker and

unanimously passed to approve the budget for the Community

Development Block Grant Fund.

Mayor Lumpkins requested a motion to approve the budget for the Sewer

and Water Fund.

MOTION A motion was made by Trustee Walker, Seconded by Trustee Pekar and

unanimously passed to approve the budget for the Sewer and Water Fund.

Trees Mayor Lumpkins stated that we previously discussed the removal of the

trees at a cost of \$30.00 a tree and there is approximately 34 trees.

MOTION A motion was made by Trustee Meeks, Seconded by Trustee Mahoney to

approve the removal of the 34 trees at a cost of \$30.00 a tree.

Bleck Engineering Co., Inc.-Recommendation of Contractor

Mayor Lumpkins stated that we had the bid opening for the CDBG paving

project and that there were six bidders. Peter Baker and Sons had the lowest bid at \$84,387.40. Bleck Engineering is recommending that we

award them the contract for this project.

unanimously passed to award the bid to Peter Baker and Sons for

\$84,387.40.

Memorial Park Mayor Lumpkins stated that he would like to get approval for \$14,200.00

to Premier Paving for the Memorial Park.

MOTION A motion was made by Trustee Pekar, Seconded by Trustee Katzel and

unanimously passed to approve a budget of \$14,200.00 to Premier Paving

for the parking lot at the Memorial Park.

Mayor Lumpkins stated that we have to put a foundation on the back side of the Memorial Park and an extension of the sidewalk. This will be done

by B.L. Weber Construction at a cost of \$7,100.00.

MOTION A motion was made by Trustee Pekar, Seconded by Trustee Walker and

unanimously passed to approve a budget of \$7,100.00 to B.L. Weber Construction for the foundation and sidewalk at the Memorial Park.
